Upon completion of the course, a final examination is administered to assess participants' overall understanding of the use of QuickBooks Pro. This final examination serves as a comprehensive evaluation, where achieving a minimum grade of C+ is required to pass the course.

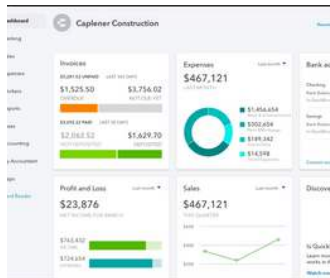
